Coming Soon! 2022-2023 Kindergarten Registration

A question many have been asking me lately is what will fall look like. At this time, I don't know exactly other than we will be on-site learning, thanks to so many we have been successful this year. What I do know is it is that time of year to begin planning for next year's incoming Kindergarten class, children who will be turning 5 on or before September 1, 2022.



Due to the Ready Schools, Safe Learners guidance we will not be able to hold our annual Kindergarten Registration Day. Instead, our Kindergarten Registration for the upcoming 2022-2023 school year will be completed on-line. We are busily at work getting everything ready for our virtual registration. Be watching for a link, which will be in the next addition of the Billie News, as well as will be sent out via Seesaw too.

2022- 2023 Returning Student On-line Registration Opens March 11th

- > Registration instructions will be mailed from the District Office the first week of March.
- All currently enrolled students need to complete the registration on-line process for the 2022 -2023 school year.
- Postcards announcing your child's teacher for the 2022 2023 school year will be mailed the first week of August to those families who have completed the re-enrollment process in the spring.

Chromebook Updates

Just a reminder Pleasant Hill School District has GoGuardian, a Chromebook extension to all district owned computers. This program is designed to help protect students from inappropriate online material. It is to help students stay focused on their academic studies when learning online.

District computers are not designed for extra extensions, watching movies, extensive searches unrelated to student assignments. These Chromebooks basically are designed to run the programs and apps the district has selected to use this year. We are asking that you assist your student with uninstalling any apps / extensions such as wallpapers, games, virtual pets, etc. so that these devices will run at their maximum capacity for school purposes.

In addition, the Chromebooks need to be restarted at least <u>weekly</u>. This updates apps (and operating systems (Chrome OS) to the newest and best for the systems. (Just closing the lid does not accomplish this) Step 1: Press and hold the *Power* button.

- Step 2: The screen dims, and a pop-up appears. Click the Power Off button.
- Step 3: Press your Chromebook's Power button to restart.

GoGuardian

GoGuardian is a software company that helps districts manage a fleet of Chromebooks. GoGuardian Admin is primarily used to filter the content of the Internet on our district-owned Chromebooks. The district's IT staff creates filtering policies that block or allow websites based on predetermined categories and assigned to students.

GoGuardian's content filtering only applies to district-owned devices.

GoGuardian keeps track of the websites that a student visits on their device. A report provides a chronological timeline of websites visited along with how much time was spent on each site. Even if the browsing history is erased, the record is still available from when they were online.

GoGuardian uses artificial intelligence and machine learning in order to block websites based on what is on the screen regardless of where the content was found. It examines the words and images on a web page for inappropriate content and if believed to be unsuitable for students, it will block the page immediately. This helps to protect students from exposure to unwanted materials accidentally or intentionally. No filtering or monitoring program is perfect, as technology in constantly changing, but it has helped alert teachers and admins to student safety issues that would have been missed or overlooked without it.

Last week we implemented GoGuardian Teacher Module which is a classroom management tool for Chromebooks. It allows teachers to see what is on the screen of every student in their classroom. They can see the active tab the student is currently looking at, as well as any other open tabs in the browser.

Teachers can close tabs for students, send messages to students, and lock student screens. Messages between a teacher and student on GoGuardian are logged. Students cannot message other students through GoGuardian, only the teacher.



Why Your Child Should Read for 20 Minutes A Day

Let's figure it out--mathematically!

Student A reads 20 minutes five nights of every week; Student B reads only 4 minutes a night...or not at all!



Student B reads 4 minutes x 5 times a week = 20 minutes.

2nd: Multiply minutes a week x 4 weeks each month.

Student A reads 400 minutes a month. Student B reads 80 minutes a month.

3rd: Multiply minutes a month \times 9 months/school year.

Student A reads 3600 minutes in a school year. Student B reads 720 minutes in a school year.

Student A practices reading the equivalent of ten whole school days a year. Student B gets the equivalent of only two school days of reading practice.

By the end of 5th grade, if Student A and Student B maintain these same reading habits, Student A will have read the equivalent of 50 whole school days. Student B will have read the equivalent of only 10 school days.

- You must have your <u>face covering on before the bus pulls up</u> to your stop. You must keep your face covering
 on while riding on the bus.
- When you get on the bus please go to your assigned seat, sit down and remain seated until you get to school
 or home.
- We are loading the bus from the back to the front. Siblings must sit together.
- No playing, touching, or moving around to sit with other students on the bus.
- When the bus comes to a complete stop, the driver will let you know when you can stand up to exit the bus.
- Buses are cleaned after each route. All seats and high touched areas are cleaned with a disinfectant.
- The Drivers at First Student are looking forward to being a part of keeping everyone safe and healthy this school year.

REMINDERS FROM THE OFFICE



<u>ABSENCES</u>: If you are keeping your child home, *PLEASE* call the office attendance line, **541-736-0411**, otherwise we will be calling you to verify your child's absence as required by law.

<u>PHONE MESSAGES</u>: We really appreciate and request that all of our families who discover throughout the school day their child's after school plans need to change <u>please call the school office before 1:30 p.m.</u> Bus notes are delivered to the classrooms around 1:45 p.m. daily.

On Early Release Days please call in the messages before 12:30 pm. It is important to allow as much time as possible on those days.

<u>Cell Phones and Digital Watches:</u> Students may bring cell phones, for safety reasons, and wear their watches to school. However, cell phones and watch volume needs to remain off during the day.
